PUBLIC NOTICE FOR SPONSORSHIP OF REPUBLIC DAY 2026

Tuesday 2nd June 2026

Mumbai

1. Purpose

The Consulate General of Italy in Mumbai wishes to celebrate the **Italian Republic Day** the **2nd June 2026** through a festive evening that will see the participation of numerous prominent figures from Italian and Indian business communities, authorities and also Italian citizens residing in India.

2. Scope of sponsorship

The Consulate General of Italy in Mumbai, on the occasion of the reception for the 2026 National Day, which will be held on the evening of Tuesday, June 2, 2026, offers the opportunity to participate as:

- a) **“Silver Sponsor”**: by a financial contribution of INR 300,000 (3 Lakhs);
- b) **“Gold Sponsor”**: by a financial contribution starting from INR 500,000 (5 Lakhs);

- c) **“Platinum Sponsor”**: by a financial contribution starting from INR 1000,000 (10 Lakhs);
- d) **“Technical Sponsor”**: through the provision of services, cultural performances, supply and display of goods and products susceptible to be used in the event with a perceived market value of INR 300,000 (3 Lakhs). The Consulate General will determine the usable quantity; any remaining value, if present, will be used in subsequent events by 2026.

The selected subjects/entities will be provided with advertising opportunities and visibility as follows:

- a) **“Silver Sponsor”**: logo on the “invitation card” sent to all invitees for the reception in Mumbai + logo on the banner placed within the premises of the reception;
- b) **“Gold Sponsor”**: logo on the “invitation card” sent to all invitees for the reception in Mumbai + logo on the banner placed within the premises of the reception + mention during the official speech+ (05) five invitations for clients/suppliers/employees, with prior intimation about the same;
- c) **“Platinum Sponsor”**: logo on the “invitation card” sent to all invitees for the reception in Mumbai + logo on the banner placed within the premises of the reception + mention during the official speech + prospective possibility of distribution of promotional material, the methods of which shall be further discussed and approved by this Consulate General + (10) ten invitations for clients/suppliers/employees with prior intimation about the same;
- d) **“Technical Sponsor”**: visibility will be provided in regard with the value statement of the goods or services provided.

The Italian Republic Day in Mumbai will be held in a Five Star Hotel/prestigious venue and is expected to be attended by around 600 invitees and will be advertised across all the official social media handles of the Consulate General.

3. General Requirement for sponsorship applications

All private and public companies, enterprises, associations, foundations and any Italian or foreign entity who does not undertake any activity in conflict with public interest are invited to present their bids.

4. Terms and conditions and method of presenting bids

Interested parties must submit their bids within 24th April 2026 to the Consulate General of Italy by writing to the email address consmumbai.eventi@esteri.it or by post or by hand delivery to:

The attached form should be filled in and duly signed and shall mention the following pieces of information:

- The identity details of the proposer and/or registered name of the company/association/foundation;
- The type of sponsorship selected with indication of the financial contribution to be made;
- A declaration of having full understanding and of complete and unreserved acceptance of the sponsorship conditions of this notice;
- Attestation of non-existence of prejudicial or restrictive conditions for contractual capability as per the provisions of Art. 80 of the Legislative Decree No. 50/2016.

5. Evaluation of the bids

Sponsorship offers regularly submitted are evaluated by the Consulate General in accordance with the criteria defined in the sponsorship notice and in compliance with the principles of economy, effectiveness, impartiality, equal treatment, transparency and proportionality. The Consulate General reserves

the right to evaluate bids on the basic principle of the highest bid or that which is economically most suitable or considered qualitatively viable.

The sponsorship bids are, however, not binding upon the Consulate General till the signing of the concerned contract.

6. Right to reject

Please note that bids of the following nature will NOT be considered:

- a) Political, trade union related, religious, philosophical propaganda;
- b) Those that may contain offensive, fanatical, racist, hateful or threatening messages and also those which are not in agreement with the laws and principles of the Italian legal order.

7. Finalisation of the sponsorship contract

Following the intimation regarding the acceptance of a bid, the contract will be finalised which shall govern the relations between the Sponsor and the Consulate General. In accordance with the decided schedule and methods, the Sponsor will provide its logo or brand, the materials that are offered and/or provide to pay the financial contribution.

In accordance with the applicable regulations, the Consulate General cannot issue any tax invoice. However, upon request, a sponsorship acknowledgement letter may be provided.

In case the event, for causes not under the control of the Consulate General, does not take place, the Parties shall jointly decide the mode of refund in case of any completed payment in the Consulate General's account.

In case the event, be postponed due to force majeure or unforeseen and urgent institutional commitments, and should the new date not be approved by the Sponsor, the Parties shall jointly decide the mode of refund in case of any completed payment in the Consulate General's account.

It is necessary to consider the Art. 6 subparagraph 2 of the Decree of 2nd Nov. 2017, n. 192 (Collaboration with Private entities), defining that in sponsorships contracts a particular clause should be included related to the right of withdrawal due to foreign policy, upon simple request, without any condition or

restriction, free of charge and without prejudice to the right of refund of any advance paid and above the amount of services already provided. In case the prospective sponsor refuses to accept the clause, the contract of sponsorship shall not be valid.

8. Right of withdrawal

If the declaration in the sponsorship intent and the provided documents are found to be false, the concerned party will be subject to stipulated penal action, leading to immediate termination of any signed contract, as also the loss of any benefits that might have been provided based on these false declarations.

9. Use of Sponsorship Funds

The Consulate General of Italy in Mumbai undertakes to allocate the funds received by way of sponsorship to cover the expenses related to the organization of the National Day 2026 and, where applicable, to support additional cultural and integrated promotional initiatives to be carried out during the year, in full compliance with the administrative and accounting regulations governing the management of the budgets of the overseas offices of the Ministry of Foreign Affairs and International Cooperation.
